

Current Rates of Smoking and Tobacco Use in Iraq

Tobacco use continues to be an epidemic in Iraq. Government complacency in the face of the tobacco epidemic protects the tobacco industry in Iraq as the death toll grows each year. Proponents of healthier societies must push for the implementation of evidence-based best practices in tobacco control to create change and reduce the negative effects of tobacco use.

Negative Effect of Tobacco Use in Iraq

Tobacco use harms both the public and fiscal health of Iraq, threatening efforts to improve equity, alleviate poverty, and protect the environment.



Societal Harms

The economic cost of smoking Iraq is 2,079,549,137,287 Iraqi dinars. This includes direct costs related to healthcare expenditures and indirect costs related to lost productivity caused by illness and premature death.



Harms Development

Tobacco spending diverts funds from the resources that families need to rise out of poverty. On average in Iraq, a smoker must spend 0.8% of GDP per capita to buy 100 packs of the most popular cigarettes in a year.



Environmental Harms

Cigarette butts are the most commonly discarded pieces of waste worldwide. It is estimated that 10,982 tons of butts wind up as toxic trash in Iraq each year, equal to 3,138 female African elephants.



Harms Health Equity The tobacco industry markets its products aggressively to lower-income populations and youth in Iraq.



Harms NCDs

Not only is smoking a major risk factor for the 4 largest noncommunicable diseases (cancer, heart diseases, respiratory diseases, and diabetes), but people living with mental illness are nearly 2x as likely to smoke as other individuals.

Impact of the Tobacco Supply Chain on Iraq

The tobacco industry profits significantly from producing and selling tobacco. At the same time, across the tobacco supply chain, there are significant negative health and economic repercussions for Iraq.



Tobacco Production

There were more than 5,000,000,000 cigarettes produced in the world in 2019, or nearly 2 cigarettes per person per day.





Tobacco Industry The total revenue of the 6 largest tobacco companies in the world was USD 362 billion in 2022, about the same as Pakistan's Gross National Income (GNI), 5x Panama's GNI and 9x Paraguay's GNI.

Tobacco Growing There were 2,343 tons of tobacco produced in Iraq in 2022 on 2,687 hectares of quality agricultural land that could have been used to grow food.

Tobacco Tax Policies in Iraq
